Permission is hereby granted for Camp Jernee/Jernee, Inc. and all persons acting with its permission, the absolute right and unrestricted permission to obtain, use, copyright and/or publish photographic portraits or pictures of the above named registrant, whether such pictures are still, moving, single or multiple or in which the registrant is in whole or in part, in conjunction with the registrant's own name or another fictitious name. It is my understanding that such picture(s) are for the purpose of art, advertising, trade and any other lawful purpose whatsoever. I understand further that I will not have any opportunity to approve or review the finished product that may be used in connection therewith or the use to which it may be applied.
